- Ensure RAMS are compliant with current legislation, industry best practice, and client requirements
- Liaise with operations, engineering, and site teams to develop safe systems of work
- Assist with task briefings, toolbox talks, and RAMS roll-out where required

Documentation & Client Close-Out

- Compile, manage, and maintain QA/QC documentation, including:
 - Inspection & Test Plans (ITPs)
 - Check sheets and quality records
 - Certification and compliance documentation
 - Red-line drawings and as-built information
- Manage documentation close-out packs and handover documents for clients
- Ensure all documents are accurate, complete, and issued in accordance with client timelines
- Act as a point of contact for client technical and quality queries

Compliance & Support

- Ensure compliance with relevant health & safety, quality, and environmental standards
- Support audits, client reviews, and inspections
- Assist in investigations relating to incidents, quality concerns, or near misses
